3. Minutes of the committee meeting held 7 August 2020 held via Zoom

Dr Helen Macdonald provided a report with the agenda to the 4 September 2020 Legatus Group meeting which contained the notes of the Legatus Group Legatus Road and Transport Infrastructure Advisory Committee meeting held 7 August 2020. General discussion included the need for data to be gathered on the bridges across the region. The Legatus Group approved the following:

- I That the Legatus Group notes the report and supports the collaborative approach with the RDAs for a Regional Roads Coordination role.
- 2 That the Legatus Group Road and Transport Infrastructure Advisory Committee provide a report to the Legatus Group on Bridges within the Legatus Group Region.

Legatus Group Road and Transport Infrastructure Advisory Committee Unconfirmed Minutes Friday 7 August 2020 held via Zoom meeting

I. Welcome:

The meeting was opened at 9.00am by Chair Helen Macdonald

2. Attendance:

3. Apologies

Stuart Roberts (Wakefield) due to poor connection, Mike Burger (Flinders Ranges), Dylan Strong (Orroroo Carrieton) due to change in meeting time and Steve Kaesler (Barossa) due to a failure to be invited to meeting.

4. Minutes of the meeting held 2 April 2020

The meeting noted that the minutes of their meeting held on 2 April 2020 were presented to the Legatus Group's 5 June 2020 meeting and that the Legatus Group received and approved the updated 2030 Legatus Group Transport Plan Road Deficiency Action Plan. The meeting resolved that the minutes were a true and accurate record of their meeting. The update on the actions from that meeting:

- An information session was held on the progress of Major Road works by DPTI
- SAROC progressing via Business Plan on a SA Regional Local Road Priorities report
- 5. 2020 SLRP Applications

The Legatus Group CEO provided a report with the agenda which outlined the variation to the committee's recommendations on the 2020 Regional Priorities. Notification received that the first 5 ranked roads were recommended by LGTAP to the July LGA Board meeting for proposed funding. This was supported the LGA Board. These have been passed onto the Grants Commission for the Ministerial approval process. As such this information is not to be taken as confirmation but as information of the process. The Legatus Group regions 5 projects recommended for proposed funding by LGTAP total just over \$2.78m which is around 25% of the funding made available for Regional Roads and around 18% of the total funding across the State. Relevant Legatus Group Council have been informed of the current status.

6. Industry Engagement Document

The meeting noted that the Legatus Group Regional Local Road Industry Engagement Document had been distributed to all Councils and RDAs and is available on the Legatus Group website.

7. Performance review HDS and the Legatus Regional Transport Plan

The Legatus Group CEO provided a report with the agenda including the acknowledgement by HDS of the issues raised. General discussion included the need to have a broader engagement across all member councils beyond the Legatus Group Road and Transport Infrastructure Advisory Committee. The regional forum was seen as a positive approach whilst there would be value in 1-2 sub-regional workshops each year.

Recommendations that a data base of relevant officers across all councils be kept and that updates are provided to them.

8. State-wide Regional South Australian Local Government Roads Priority List

The meeting noted the report by the Legatus Group CEO that this is now a SAROC Business Plan project with inclusion of DPTI and the Grants Commission. Mike Wilde provided an update that at a high level this approach makes sense although there is some impact on progress currently due to the recent Government Department and Minister changes. Noted that better alignment between councils along with consistent data would be of assistance. Mike advised that the Dept have noted the proactive approach the Legatus Group has taken on this matter. Also, to be considered is clearer approach around road transfers.

9. LGA Heavy Vehicle Access Liaison Officer

The meeting noted the background report by Toni Clarke as the newly appointed LGA Heavy Vehicle Access Liaison Officer. Toni provided a presentation on the role which included the key priorities of:

- Empower and support
- HV Access Tools RAVRAT NHVR Portal
- OSOM Review recommendations
- National harmonization / notices
- Higher productivity freight vehicles

Toni is contracted for 2 years and the meeting agreed with value in a series of State-wide Webinars and for Toni to be one of the presenters for the next Legatus Group Roads Forum to be held in the first quarter of 2021. The meeting supported this new role and it was suggested that there are 3-4 subregional workshops as an initial introduction and that the Legatus Group CEO will provide support (note dates 11-12 November).

10. Legatus Group 20/21 Business Plan and Budget

The committee noted the report by the Legatus Group CEO and were supportive of the approach for:

- Legatus Regional Roads Coordinator
- Scio-Economic Impacts report based on the regional road's deficiency
- Progress with independent support for the 2021 SLRP Roads and Database updates

Kelly-Anne Saffin outlined discussion held with the Legatus Group CEO and information provide to the committees Chair. This included an interest from the RDAs to partner with the Legatus Group through the Road and Transport Infrastructure Advisory Committee to look at targeting Commonwealth Funding approaches. The example discussed was The WA Wheatbelt Secondary Freight Network. The meeting discussed the need for a broader approach and look to includes bridges and rail crossings.

Consensus from the meeting was to support a collaborative approach with the RDAs.

II. Stage 2 Restricted Access Vehicle Route Assessment Tool (RAVRAT)

The meeting noted the report by the Legatus Group CEO and Toni outlined that there has been some work with the Queensland LGA and this will continue to be progressed via SAROC and the Regional LGA EOs.

5. 2030 Legatus Group Regional Transport Plan FY 2020/21 and SLRP

6. State-wide Regional South Australian Local Government Roads Priority List

Discussions have continued with DIT and Grants Commission. The Commission are in the process of discussions with DIT about the future of their GIS and the greater concept of a centralised local roads database with a number of critical stakeholders including the Regional LGAs. The database may be similar to that of the Location SA database, but with more detail. They have not yet landed anything specific on this.

7. Legatus Socio-Economic Impacts Road Deficiency

The Legatus Socio-Economic Impacts Road Deficiency has an allocation of \$25,000 in the 20/21 legatus Group Budget for a consultancy to identify an initial level of impacts to community and industry in areas such as productivity and costs re connectivity due to the current level of deficiency in the funds available for the regions local roads. This is designed to complement the Legatus Group Regional Local Road Industry Engagement Document and the SA Regional Road Priority list and provided data in supporting increased assistance for funding.

8. Stage 2 Restricted Access Vehicle Route Assessment Tool (RAVRAT)

As requested by SAROC at its meeting in March 2020, the LGA Secretariat liaised with other state and territory local government associations and the Australian Local Government Association regarding the possibility of coordinating a discussion with Australian Road Research Board and the National Heavy Vehicle Regulator the further development of the Restricted Access Vehicle Route Assessment Tool for unsealed roads. While there is no immediate interest from other jurisdictions, the meeting agreed that Simon Millcock and Lea Bacon meet and include Toni Clarke and Peta Smart to discuss funding opportunities. There is continued interest in seeing how the tool can be further designed for unsealed roads from South Australian councils.

9. Other Business

Dr Helen Macdonald

South Australian State Government

Local Government Infrastructure Partnership Program

The closing date council applications is 29 January 2021.

The 2020-21 South Australian State Budget includes a new \$100 million Local Government Infrastructure Partnership Program. The program will provide councils with dollar for dollar funding for a wide range of infrastructure projects that will support businesses and create local jobs.

The State Government will provide grants to councils for up to 50 per cent of the cost of approved infrastructure projects. Councils may fund their contribution either through their own reserves or borrowings.

Projects can also leverage support from other funding partners, including the Commonwealth Government and/or local businesses. As such, the program is intended to leverage at least \$200 million investment in local government infrastructure.

Applications require a business case, a project delivery timetable, information on employment of South Australians, and an undertaking to maximise the use of local contractors during the construction phase.

Eligibility summary:

- Councils may apply individually, as part of a consortium, and for more than one project
- Projects may include construction or major renewal, replacement or upgrades
- Projects must provide economic growth and improve local community infrastructure
- Projects must not be in the council's existing 12-month budget. However, further stages of development are eligible provided the stage is not scheduled to commence and has yet to source sufficient funding.
- Projects already funded through Federal or State Government programs are not eligible.
- State Government contribution is up to 50 percent of the project. The reminder of project funding can include contributions from third parties eg. from a sporting/community club towards an upgrade of the facilities or Commonwealth Government funding.
- Projects must be shovel ready defined as be able to commence construction within 12 months of approval of the application (and not at the planning/design phase)
- Councils must maximise the use of local contractors during the construction phase.
- Projects must have a GST exclusive cost of at least \$1 million, but may include single programs, related projects and a program of works.
- Smaller regional councils may apply on a case by case basis for projects less than \$1 million.

Commonwealth Government

I. Financial Assistance Grants

In 2020-21 the Australian Government will provide \$2.54 billion in untied funding to local governing bodies under the Financial Assistance Grant program. This includes \$1.3 billion which was brought forward from the 2020–21 estimate and paid to states and territories on 25 May 2020.

The remaining 2020-21 allocation to states and territories will be paid in four equal quarterly instalments scheduled for August, November, February, and May.

A summary of the allocation for each South Australian council is available on the Commonwealth's website.

2. Local Roads and Community Infrastructure Program

In May 2020, the Australian Government announced an initial \$500 million for a new Local Roads and Community Infrastructure Program (LRCI Program). A \$1 billion extension of the LRCI Program was announced through the 2020–21 Budget.

The program seeks to support councils to deliver priority local road and community infrastructure projects, supporting jobs and the resilience of local economies to help communities' recovery from the COVID-19 pandemic. SA councils can expect to share in around \$76 million in funding through the LRCI program in 2020/21, and a further \$44.6 million next financial year. Funding allocations are determined by formula and consider road length and population. SA councils shared in approximately \$40 million of the initial \$500 million funding allocation.

The Commonwealth Government's information currently states that allocations under the extension of the program will be available shortly and that councils will be able to access funding under the extension from I January 2021. The LGASA is currently liaising with the Commonwealth via ALGA and will provide further information as it becomes available.

3. Black Spot Program

As part of the Local and State Government Road Safety Package announced in the 2019-20 Budget, the Australian Government has committed an additional \$50 million per year from 2019-20 to the Black Spot Program.

The Government is providing \$1 billion to the Black Spot Program from the 2013-2014 financial year to the 2022-2023 financial year, with an on-going commitment of \$110 million each year following.

The Federal Budget 2020-21 estimated the following allocations:

- \$137 million 2020-21
- \$137 million 2021-22
- \$117 million 2022-23
- \$110.0 million 2023-24
- 4. Infrastructure Investment Road Safety and Upgrades -

\$2B over 2 years from 2020-21 (so 18months left) to deliver small scale projects & can include cycleways. This funding goes to States/Territory Governments, but States can pass on to local

governments. Advice from Federal Department of Infrastructure is that South Australia's allocation is \$168 million.

5. Bridges Renewal Program

The Bridges Renewal Program (BRP) funds the upgrade and replacement of bridges to enhance access for local communities and facilitate higher productivity vehicle access. As part of the Local and State Government Road Safety Package announced in the 2019-20 Budget, the Australian Government has committed an additional \$25 million per year to the BRP from 2019-20.

The Government will provide \$640 million from the 2015-2016 financial year to the 2022-2023 financial year, with an on-going commitment of \$85 million each following year.

The Federal Budget 2020-21 estimated the following allocations:

- \$89.7 million 2020-21
- \$108.5 million 2021-22
- \$91.1 million 2022-23
- \$91.1 million 2023-24

Funding Round Six

The date for the opening of Round Six has not yet been decided. In advance of the next funding round, the LGA will continue to raise with the Minister for Infrastructure and Transport and Regional Development, our proposal to change to the Bridges to Renewal Program to allow for multiple council projects within a certain threshold to be combined to form a single regional application, in order to give a broader assessment of the productivity and economic benefits. This would allow the Commonwealth to support the necessary, but smaller, projects through the program.

6. Heavy Vehicle Safety and Productivity Program

The Heavy Vehicle Safety and Productivity Program (HVSPP) funds infrastructure projects that improv the productivity and safety outcomes of heavy vehicle operations across Australia.

As part of the Local and State Government Road Safety Package announced in the 2019-2020 Budget, the Australian Government has committed an additional \$25 million per year to the HVSPP from 2019- 2020. The Government will provide \$508 million to the HVSPP from the 2013-2014 financial year to the 2022-2023 financial year, with an on-going commitment of \$65 million each year following.

Funding Round Eight

The date for the opening of Round Eight has not yet been decided.

ALGA and LGASA advocate for:

• Strategic Local Roads Investment Program - \$300M per annum for 5 years – covers capability, system gaps, planning gaps and knowledge gaps.

7. Roads to Recovery Program

The Roads to Recovery Program supports the maintenance of local roads, which facilitates greater access for Australians and improves safety and economic and social outcomes. As advocated by the LGASA and ALGA, the Roads to Recovery Program does not contain a sunset

clause under the National Land Transport Act 2014, meaning no new legislation is required for the continuation of the program.

As part of the Local and State Government Road Safety Package announced in the 2019-20 Budget, the Australian Government has committed an additional \$100 million per year to the Roads to Recovery Program from 2019-20. From 2013-14 to 2023-24, the Government will provide \$6.2 billion under the Roads to Recovery Program, with an on-going commitment of \$500 million each year following.

On 6 November 2019, the Government announced \$138.9 million additional Roads to Recovery funding in the 2020 calendar year for the 128 Local Government Areas eligible for the Drought Communities Programme Extension.

The Federal Budget 2020-21 estimated the following allocations:

- \$591.7 million -2020-21
- \$499.5 million 2021-22
- \$499.5 million 2022-23
- \$476.7 million 2023-24

Roads to Recovery Program allocations have been determined based on the recommendations of the Local Government Grants Commissions in each jurisdiction.
