4. BUSINESS ARISING NOT OTHERWISE ON THE AGENDA

4.1 Rating Equity

Reports for Discussion

From: Simon Millcock, CEO, Legatus Group

Recommendation: For discussion.

Background

The LGA has continued to hold discussions with the relevant Government Departments and the matter has continued to be an agenda item for SAROC. Following information in late May 2021 from the LGA there has been correspondence by the Legatus Group Chair to Ministers Dan van Holst Pellekaan, Vickie Chapman and Rob Lucas which contained the following:

Subject: Fair rates for electricity generators

On behalf of our 15-member council the Legatus Group understands that State Government is reconsidering the issue of council rates that can be levied on land used for electricity generation.

The current relevant 8 Legatus Group Councils who are directly impacted are Barossa, Clare & Gilbert Valleys, Goyder, Northern Areas, Peterborough, Port Pirie, Wakefield and Yorke Peninsula.

The Legatus Group have been actively engaged on these matters with the State Government through the LGA and instigated the relevant independent reports by the AEC Group.

This letter asks you to support the required changes in legislation to address the rating constraints for electricity generators currently being experienced by South Australian councils.

The AEC Report found that:

- Current SA rating regulations do not enable councils to recoup their expenditure on servicing electricity generators - either during the construction phase or on an ongoing basis.
- These costs are borne by other ratepayers and has a distorting effect on markets and local economies.
- SA councils are significantly disadvantaged in their ability to rate, compared with their interstate counterparts, particularly in Victoria and Queensland.
- Energy investment location decisions are primarily made in consideration of electricity generation efficiencies (access to wind, sun, fossil fuels) and the ease with which connection can be made to the national grid.
- The introduction in SA of similar rating practices to Victoria will not impact the commercial viability of energy sector projects, and therefore will not influence location decisions for investments in such projects.

• If councils were able to collect fair rates, up to 43 FTE jobs could be created, most of them in regional South Australia. This would have a multiplier effect through local economies. Alternatively, the rates burden currently imposed on other business and residential ratepayers could be reduced.

The Legatus Group supports the LGA Advocacy position which is that the elected representatives of local communities should be the body setting council rating policy. This includes our support to the LGA position that this relates to **Renewable Energy Transmission only** and seeking for legislation to be changed to enable councils to set fair rates on land used for renewable electricity generation. We note that:

- The LGA in deferring its request for the government to review rating arrangements for fossil fuel electricity generators. It appears that many of these generators have indentures and other restrictive agreements relating taxes and rates. These might take some time to work through.
- The LGA is deferring its request for the government to review rating laws for land used for electricity transmission. The LGA does not believe that changing these laws would have a major impact on property values or council rates. Whilst a change to rating laws might be minimal, it could have an impact on a very large number of parcel of lands.

The Legatus Groups approach has been based upon changes to state legislation that are achievable and that will deliver the maximum benefit to the sector and equity when compared with other states. We are pleased that this has been supported by the SA Regional Organisation of Councils and by the LGA Board

Colin Davies assisted with the 2021/2022 draft budget and is currently working on Internal Controls / Disaster Recovery matters. Colin will work on the Long-Term Financial Plan which needs to occur in alignment with the Strategic Plan Review.

4.3 SA Coastal Council Alliance

Reports for Discussion

From: SA Coastal Council Alliance

Recommendations: See below

Background

The following report has been received from SACCA. Mayor Parkes and Adam Gray are unable to attend in person. Adam Gray advised he would engage with Legatus Mayors that are represented on the SACCA Committee and request that they speak to this issue on behalf of the SACCA Committee.

RECOMMENDATION

- I. That the Legatus Board support the SA Coastal Councils Alliance proposed funding and governance model.
- 2. That the Legatus Board provides guidance to the Legatus CEO on the preferred approach to recover SACCA member subscriptions for 2021/22.

BACKGROUND

In February 2021, the SA Coastal Councils Alliance (SACCA) Executive Officer Adam Gray, wrote to Mayor Peter Mattey, Legatus Chairman seeking Legatus support for the proposed SACCA Funding and Governance model.

This item was considered by the Legatus Board at its 5 March 2021 meeting and the following motion was resolved.

Motion: Defer any decisions re the item and include on the agenda for the Legatus Group II June 2021 meeting and await feedback from South Australian Regional Organisation Councils. Moved: Mayor Leon Stephens Seconded: Mayor Ben Browne CARRIED

The SACCA is seeking endorsement from the Legatus Board for its proposed governance and funding arrangements from 30 June 2021. The discussion paper (included in the 5 March 2021 Legatus Board agenda) details that the SACCA is seeking \$2,000 + GST per coastal Council for the 2021/22 financial year via the regional LGA's so it can continue to operate. For Legatus this is a contribution of \$12,000 + GST (based on 6 regional coastal Councils).

Regional LGA's are being invoiced for members fees in recognition of the proposed governance arrangements (regional LGA nominees on the SACCA Committee) and that coastal issues impact every SA Council, similar to drought and other climatic phenomena. Therefore, it is for each individual LGA to consider if the SACCA fee is spread across all LGA members or just coastal council members.

Since February 2021 other regional Local Government Authorities have considered this matter. The following is a summary of their discussion.

- The Limestone Coast LGA has resolved support for the proposed model. All LCLGA councils will contribute financial support to SACCA.
- Eyre Peninsula LGA has resolved support the proposed model for at least 2021-22. Only coastal Councils will contribute to support SACCA.
- Southern & Hills LGA has resolved indicative support however is currently consulting with each of its member Councils regarding the funding model (whether all councils or just the coastal councils contribute)
- Coorong Council will consider this matter at its next meeting.
- Metropolitan Seaside Councils Committee (MSCC) is currently undertaking its own governance and strategic review and will consider its relationship with SACCA as part of its review

At its 18 March 2021 meeting the SAROC Committee considered a Coastal Management report and resolved to invite SACCA Chairperson, Mayor Keith Parkes and Executive Officer Adam Gray to its May 2021 meeting to provide an update on SACCA.

Mayor Parkes and Adam Gray attended the SAROC meeting on 20 May 2021 and provided an update on the SACCA Funding and Governance model as well as recent achievements. SAROC members considered this item and while no specific resolution was recorded members of SAROC indicated majority support for SACCA and its objectives.

Representatives from both SACCA and the LGA have also agreed to formalise a relationship using a Memorandum of Understanding. This MOU defines a shared/collaborative approach to Council coastal matters as well as a delineation of roles and responsibilities. It was acknowledged that SACCA provides a great 'focus' resource to support and enhance the lobbying efforts of the LGA.

KEY ISSUES

- 1. The SACCA Committee is seeking support for its draft governance and funding model.
- 2. The funding approach is to cover SACCA administration costs from members fees and leverage external funding for specific approved projects.
- 3. The SACCA will be seeking approximately \$2,000 per regional coastal Council and invoicing the regional LGAs and Metropolitan Seaside Councils Committee
- 4. It is for the Legatus Board to determine how it seeks to recover these costs from its members. Options for consideration include.
 - a. Only Legatus coastal Councils contribute (\$2000+GST / Council x 6) *, or
 - Contributions are spread equally across all Legatus Council members (\$858+GST / Council x 14) *
 - c. Legatus utilise existing retained funds.

(* noting that for the purpose of engaging Port Pirie Council SACCA considers this Council as a member of the Upper Spencer Gulf Common Purpose Group)

6. The SACCA will be supported (auspice) by the Limestone Coast LGA for the immediate future.

4.4 Funding equity for local road upgrades

\$80 Million over the next 3 years to address the regionally significant roads. These roads have at least one major deficiency and are in our councils forward works plans. We are appreciative of the Federal and State Government assistance, but this is insufficient and disproportionate to the costs experienced in the region. Without this assistance it is limiting growth and productivity for the increases in freight transport and visitation by

The Legatus Group have released a report into the socio-economic impacts by not funding these roads and it is estimated that the cost to the community of not addressing roads deficiencies costs at least 2.5 times the cost of investment. The continuing degradation the roads is also increasing the risk of road accidents that has cost the region over \$488M (between 2015-2019).

The Legatus Group councils are making good use of the current limited funding programs. However, the gap between what is gained and what is needed is large. The

current funding programs are either competitive or based on a capita and kilometre formula and reduce the equity for a region characterised by several smaller, low population and with massive road networks.

At least \$80 million is needed to address the 454km deficiencies in the key freight, tourism and community access roads that are already in the forward works plans. An additional 1,005km of roads with deficiencies are identified which are not in councils forward works plans, that are yet to be evaluated.

The Federal Budget included a \$1 billion expansion of the Commonwealth's Local Roads and Community Infrastructure Program. The LGA advised that the sector is grateful that secure ongoing supplementary road funding for SA was successful. The \$20 million per year allocation was due to run out in June 2021 but has now been extended for another two years.

Note this matter is also subject to item in the Legatus Group Road and Transport Infrastructure Advisory Committee report.

The Wakefield Regional Council endorsed the following motion to ALGA.

MOTION:

This National General Assembly calls on the Australian Government to work with state/territory Local Government Grants Commissions across Australia, to ensure the allocation of federal road funding is distributed to local governments in accordance with the National Principles of horizontal equalisation as required by the Local Government (Financial Assistance) Act 1995.

NATIONAL OBJECTIVE:

The Local Government (Financial Assistance) Act 1995 (the Act) requires the Minister, in formulating the National Principles for the allocation of roads funding, to have regard to the need to ensure road funding is allocated, as far as practicable, on a full horizontal equalisation basis. Section 6(3) of the Act defines horizontal equalisation as being an allocation of funds that:

- ensures each local government body in a state/territory is able to function, by reasonable effort, at a standard not lower than the average standard of other local government bodies in the state; and
- takes account of differences in the expenditure required to be incurred by local government bodies in the performance of their functions and in their capacity to raise revenue.

This means councils that incur higher relative costs in providing normal services and have a limited rate base should receive relatively more grant money. Similarly, councils with lower relative costs and a strong rate base should receive comparatively less grant money.

SUMMARY OF KEY ARGUMENTS:

The purpose of this motion is to address the inequitable distribution of federal road funding to councils across Australia, which fits the theme of the National General Assembly of 'Working Together' for our Communities'.

Councils that cannot generate significant amounts of their own revenue are dependent on grant funding from other levels of government, including Identified Local Roads and Roads to Recovery Funding. The finances of councils with small populations and large road/freight networks is under pressure, which limits their ability to maintain critical assets and grow their region.

In accordance with Section 16 of the Act, the Australian Government's Department of Infrastructure, Transport, Regional Development and Communications, provided to the Hon Mark Coulton MP, in March 2020, the 2016-17 Local Government National Report (most recent report). The report presents details on the distribution of the Australian Government's financial assistance to local governments, specifically the Financial Assistance Grants (FAGs), which includes the General-Purpose Grant and Identified Local Roads Grant. It should be noted that Roads to Recovery Funding is generally distributed in the same way.

The following table presents information taken directly from the 2016-17 Local Government National Report. It would appear from the data that the National Principle of full horizontal equalisation for the allocation of roads funding is <u>NOT</u> consistently applied by state/territory Local Government Grants Commissions; as a result, many rural councils are financially disadvantaged.

2021 National General Assembly Motion presented to Wakefield Regional Council 18 February 2021

Report Purpose

To seek Council approval for the CEO to submit to the Australian Local Government Association's 2021 National General Assembly, a motion that calls on the Australian Government to work with state/territory Local Government Grants Commissions across Australia, to ensure the allocation of federal road funding is distributed to local councils in accordance with the National Principles.

Officer Recommendation

That Council authorises the CEO to submit the attached Motion, National Objective and Key Argument to the 2021 National General Assembly, that calls on the Australian Government to work with state/territory Local Government Grants Commissions across Australia to ensure the allocation of federal road funding is distributed to local councils in accordance with the National Principles.

Discussion

The Australian Local Government Association (ALGA) has advised that the 2021 National General Assembly (NGA) will be held in Canberra from 20 to 23 June 2021. The NGA is a major national event on the local government calendar and attracts Mayors, Councillors and Senior Managers from across Australia.

This year's NGA theme is 'Working Together for our Communities'. This theme acknowledges the need to come together and with other partners, including the Federal Government.

In November 2020, ALGA called for Notices of Motions for National General Assembly. For a Notice to be eligible for inclusion in the NGA Business Papers, and subsequent debate on the floor of the NGA, motions must meet the following criteria:

- 1. Be relevant to the work of Local Government Nationally.
- 2. Not be focussed on a specific location or region unless the project has national implications. You will be asked to justify why your motion has strategic importance and should be discussed at a national conference.
- 3. Be consistent with the themes of the NGA.
- 4. Complement or build on the policy objectives of your state and territory local government association.
- 5. Be submitted by a council which is a financial member of their state or territory local government association.
- 6. Propose a clear action and outcome i.e. call on the Australian Government to do something.
- 7. Not be advanced on behalf of external third parties that may seek to use the NGA to apply pressure to Board members, or to gain national political exposure for positions that are not directly relevant to the work of, or in the national interests of, local government.

At the February 2021 meeting of Council, Council approved the attendance of the Mayor and CEO to the NGA and also resolved the following:

That Wakefield Regional Council submits a motion for inclusion National General Assembly 2021 of the Australian Local Government Association to the effect of:

'This National General Assembly calls on the Australian Government to work together with Local Government across Australia to develop strategies and funding to reverse the imbalance between urban and regional communities in regards to population growth and distribution, that is resulting in a decline in new or upgraded community infrastructure, business growth, job creation and the declining number of regional parliamentarians at both a Federal and State level required to address these imbalances that are significant for regional communities'. and for the CEO to bring a report to the March Council Meeting.

In response to the proposed NGA Motion, administration conducted a significant amount of research, from a <u>national</u> perspective (a key criteria requirement) and began to consider how to best pitch the key argument that would support the above motion. It quickly became clear that due to the number of complex elements within the proposed NGA Motion, that it would be extremely challenging to put forward a <u>strong</u> argument within the strict 300 words limit.

Administration subsequently consider an alternative approach that would narrow the focus, strengthen the argument and still supports key elements the proposed motion such as the funding imbalance between urban and regional councils, the impact smaller populations have on rural council's ability to attract road funding and the resulting decline in the quality of rural infrastructure.

Attached is a draft submission to the 2021 National General Assembly for Council's consideration. The submission satisfies ALGA's mandatory requirements which include the Motion (150 words), the National Objective of the Motion (200 words) and Key Argument that support the Motion (300 words).

The key document used to support the argument within the attached draft submission is the Australian Government's Department of Infrastructure, Transport, Regional Development and Communications' 2016-17 Local Government National Report (the most recent report), which was provided to the Hon Mark Coulton MP, in March 2020. The report presents details on the distribution of the Australian Government's financial assistance to local governments, specifically the General-Purpose Grant and Identified Local Roads Grant. It should be noted that Roads to Recovery Funding is distributed in the same way. Given the size of the 2016-17 Local Government National Report (226 pages) it has not been included as an attachment this report can be found https://www.regional.gov.au/local/publications/reports/index.aspx

The attached draft submission tells a complex story in only a few words, with the table (see below) highlighting that there is inconsistency from state to state in relation to how the Federal Government's road funding is distributed between rural and urban councils within each state.

The Federal Government's National Principles require, as far as practicable, the distribution of funding on a full horizontal equalisation basis. Section 6(3) of the Local Government (Financial Assistance) Act 1995 defines horizontal equalisation as being an allocation of funds that:

- ensures each local government body in a state/territory is able to function, by reasonable effort, at a standard not lower than the average standard of other local government bodies in the state; and
- takes account of differences in the expenditure required to be incurred by local government bodies in the performance of their functions and in their capacity to raise revenue.

This means councils that incur higher relative costs in providing normal services and have a limited rate base should receive relatively more grant money. Similarly, councils with lower relative costs and a strong rate base should receive comparatively less grant money.

Even though Council's proposed motion presents a strong case, there is no guarantee it will make the NGA Business Papers. All motions submitted will be reviewed by the ALGA Board's NGA Sub-Committee, as well as by state and territory local government associations to determine their eligibility for inclusion in the NGA Business Papers. When reviewing motions, the Sub-Committee considers the importance and relevance of the issue to local government and whether the motions meet all the criteria.

It is recommended that Council sits tight until it is advised by ALGA whether or not its motion has been included in the NGA Business Papers. Once this is known, it is recommended that Council considering additional/alternative advocacy channels such as other councils, Legatus Group, SA Grants Commission and Federal Members.

6.2 CEOs Performance Review

Background

McArthur's commenced the external review of the Legatus Group CEOs performance following the 5 March 2021 Legatus Group meeting. This review covered the work of the CEO for the previous 12 months. All Board Members, selected CEO's, Staff and the CEO were given the opportunity to provide comments and scoring against 7 Key Result Areas. External Stakeholders were also invited to provide comments on their interactions with the CEO. There was 67% participation from the Board, 100% participation from CEO's and 50% participation from staff.

On 3 May 2021 Rebecca Hunt Divisional Manager Recruitment and Human Resource Consulting from McArthur held a meeting with Mayors Mattey, O'Brien and Reid who had been delegated to manage the performance of the Legatus Group CEO.

The Legatus Group CEO was then provided with a copy of the performance review report which Mayors Mattey, O'Brien and Reid approved to be included in the agenda for the 11 June Board meeting (Attachment 1).

The Legatus Group CEOs current contract of employment expires on 5 June 2022 and he has expressed an interest to continue beyond this date. There has been no increase in the CEO's renumeration for the past 2 financial years since the 25 May 2018 Legatus Group decision to approve a CPI increase for financial year 2018/2019.

As reported to the 3 July 2020 Legatus Group Special Meeting the following breakdown of comparisons was relevant for Regional LGA Executive Officers wages and conditions.

7 ITEMS REFFERED BY COUNCILS

7.1 New Planning and Design Code

Reports for Discussion

From: Copper Coast Council

Recommendations:

- I. That Legatus forward a Motion to the Local Government Association to request the State Government to undertake the implementation of an Independent anonymous survey of the existing Planning Portal and current processes of the new Planning and Design Code.
- 2. The results of such independent, anonymous survey to be provided to all Councils.
- 3. That the Local Government Association work with the State Government to implement the outcomes of the independent anonymous survey.
- 4. The Local Government Association also work with the State Government to streamline the current processes and Planning Portal of the new Planning and Design Code, so that Development Applications are progressed more efficiently, leading to better outcomes for Council, Applicants and less cost.

Background

As members are aware, the State Government has introduced the new Planning and Design Code. The Copper Coast Council has experienced some difficulties and concerns regarding the new Planning Portal.

The Copper Coast Council since the introduction of the new Planning Portal on Ist March 2021 has seen a significant increase in Development Applications. The Council has received 210 Development Applications from 19 March 2021 to 31 May 2021 compared to 94 applications for the same period in 2019, before COVID-19 (an increase of over 220%).

The issues highlighted are as follows:-

- The Planning Code in general and the Planning Portal in itself is not as was originally outlined.
- The system in its current form has a heavier dependence on qualified Planning staff compared to administrative staff being able to progress and assist applications.
- Customer service requests are taking up much more time of our technical staff's time.
- It is difficult to progress straight forward applications quickly.
- The system in its current form puts a greater financial burden on councils (without adding much value at all) which will be exacerbated when individual planning staff members are on leave. Council will be required to engage the services of additional resources during holiday leave.
- Due to the time taken to process applications and the incessant demands, the new system has had mental health impacts on Planning staff (both technical and administrative).

It is considered that all Councils should have the opportunity for an independent anonymous_survey undertaken of the new Planning and Design Code, Portal system and processes which could be completed by Council Staff, Developers and Consultants. There are no doubt areas where the Planning Portal and current processes can be improved, so that the system is streamlined; thereby leading to better outcomes for Council, Applicants and less cost.

8.2 Project Officer updates

Paul Chapman - Project Manager CWMS and Waste

CWMS

- CWMS training course: awaiting confirmation of the content by LGA when Legatus will prepare a
 request for quotation to have the material scripted in readiness for it being produced in digital video
 form.
- CWMS Services Arrangements: a request has been made to the LGA to extend the CWMS Services
 Arrangements through until June 2022. The Arrangements would include, among other things,
 support for the LGA CWMS Management Committee and for a workshop with each Regional LGA
 during 21/22.
- Condition monitoring via remote sensing: this project involved UniSA, the Copper Coast Council,
 Legatus and technology firm, IPACS. Initial reports have been prepared for the Council. Other
 Legatus Councils have expressed interest in the project with the Light District Council installing
 sensors and the Wakefield District Council considering. An Addendum to the Research Agreement
 with the UniSA will be prepared.

 Research projects: two doctoral students have completed their internships: one on Expansion options for CWMS and another Making and Using Organic Compost. A third Internship, looking at the challenges along the organics supply chain and possible means of addressing them, will be completed on 8th June.

Waste Management

Discussions have been conducted to develop funding applications for regional waste management infrastructure. One proposal is to work with other Regional LGAs to conduct an initial study of regional MRFs. The study would define the MRF, determine its optimal position and estimate the cost implications for regional Councils.

A second proposal is to further investigate establishing a pilot organic processing plant at Peterborough. Initial discussions have formed a Reference Group comprised of representatives of Peterborough, Mount Remarkable and Northern Areas Councils, processing firm, Peats Soils, and Prof Guy Robinson from the University of Adelaide. The Legatus Group would manage the work of the Reference Group.

Bridget Johns - Community Collaborator.

Collaborating with interested councils and community groups that support volunteers to be part of building thriving communities.

- I. Drought Wellbeing Project: Adelaide University has been engaged to complete a research gap analysis review of services available across the region. A progress review meeting was held in May with the researcher where 56 services were identified in the seven northern council areas of the Legatus region. Adelaide University will be presenting a short update at the Board meeting. In addition, a program developed by a local clinical psychologist to build skills for resilience and wellbeing across our rural communities is another opportunity we are investigating funding in the short term.
- 2. Legatus Visitor Information Centre (VIC) Forum: The "Telling Tales" Visitor information Services workshop was held on Thursday 6th May with 32 attendees. The workshop followed the State VIC Conference. Storytowns shared an approach to help tourists find gems through walk, drive and virtual podcast tours and Dr Heather Robinson shared the latest national and international research into the impacts of engaging with mixed media technologies for tourism and the creative industries outlined in the Legatus Tourism and Mixed Realities report. Attendees left the workshop with ideas for encouraging more mixed realities opportunities in their regions.
- 3. Creating Brighter Futures: This project in its current form has stalled. From strong interest following the "Telling Tales" Visitor information services workshop in towns, councils and community groups sharing the stories of their towns, we are working with Kristine Peters from KPPM Strategy and community development officers to adjust the program.
- 4. The final element of the Mid North Youth Volunteering project involved Youth Mental Health Training. Working with C&GVC Youth Development Officer and Lifeline young people in the C&GVC, Wakefield Regional Council and Goyder Regional Council will participate in a new training course. The REACH (Recognise, Engage, Ask, Check, How) course is a new course aimed at young people who want the mental wellbeing training. One training course was held in April

2021 in Clare and the other session had to be postponed as the school had not followed through to gain parental approval for the students to attend. It is hoped this session will be held in June.

Bridget attended the National Rural Women's Coalition Rural, Regional and Remote Women's Canberra Muster Leadership Program in Canberra 14-18 March as the only South Australian delegate and one of the 10 women from across Australia chosen to attend. The four-day program included learning skills for effective advocacy on issues, examining the knowledge, skills and capacities required to lead effectively, public speaking training to increase confidence in the Boardroom environment, governance training and a visit Parliament House to gain a better understanding of political decision-making processes and advocacy.

During the visit to Parliament House, Bridget had the opportunity to meet and hear from Deputy Prime Minister Hon Michael McCormack MP, Minister for Foreign Affairs and Minister for Women Senator the Hon Marise Payne, Minister for Trade, Tourism and Investment Hon Dan Tehan MP, Minister for Agriculture, Drought and Emergency Management Hon David Littleproud MP, Minister for Defence Industry Hon Melissa Price MP, Assistant Minister for Regional Development and Territories Hon Nola Marino MP, Mr Rowan Ramsey MP, Hon Warren Entsch MP, Mr Ken O'Dowd MP, Deputy Speaker Mr Llew O'Brien MP, Hon Warren Snowdown MP, Hon Tanya Plibersek MP and Senator Lidia Thorpe.

11. 2021 / 2022 Legatus Group Business Plan and Budget

Reports for Discussion

From: Simon Millcock, CEO, Legatus Group

Recommendation: That the Legatus Group adopts the 2021/2022 Legatus Business Plan and Budget using draft 2 of the budget.

The Legatus Group Audit and Risk Management Committee meeting held on 3 June 2021 noted that the 2021/2002 Legatus Group Business Plan and Budget were distributed in accordance with the Charter and that the level of reserves identified in the 2021/2022 Draft Business Plan (Attachment 5) and Budget (Attachment 6) aligns with their previous recommendations.

On 16 April 2021, the 2021/2022 Budget Draft was prepared in consultation with the Finance Manager, including the break down for each project and this was distributed to all constituent councils.

This included the following notes on the level of reserves:

It has been recognised by the Board, Audit Committee and Management Group that the Legatus Group is seeking to have a manageable reserve that allows for around 18 months of core operational expense with some contingencies for any priority issue. The amount which has been agreed on previously is \$450,000. The 2021/2022 draft budget allows for \$480,000 which includes the allowance for up to \$100,000 relating to supporting the 3rd year for Drought Wellbeing which has not been utilised in the first 2 years.

There was no membership fee increase in 2020/2021 which is the only core source of income for the Legatus Group.

The LGA have advised that they will continue the base-level Regional Capacity Building Allocations indexed to the Adelaide CPI for one more year (2021-22) subject to the existing conditions. There will then be a review to inform the future of the Regional Capacity Building Allocations.

The 2021/2022 draft budget is seeking to use some of the reserves to continue with the advocacy and project work that can then leverage in partnership with councils and or others to gain increased resources for the region via grants.

Note there will need to be flexibility in the budget process as many grants will not be known at the time of developing the budget.

Key Assumptions

- 1. Membership fees 2% increase in fee
- 2. LGA regional capacity grant of \$42,000 confirmed
- 3. LGA R&D funding will need to be applied for
- 4. LGA CWMS funding is being applied for
- 5. LGA, State and Commonwealth grants will need to be applied for. As such there would be no contracts entered or commencement of projects which require external funding until this funding is secured for those projects.

The Charter outlines that the proposed Annual Business Plan and the Budget must be referred to the Constituent Councils at least eight (8) weeks prior to the date of the meeting at which the budget is to be adopted.

Constituent Councils **may** comment on the Annual Business Plan and the Budget in writing to the Chief Executive Officer at least ten (10) business days before the meeting at which the budget is to be adopted or through its Board Member at that meeting.

The Legatus Group must adopt the Annual Business Plan and Budget after 31 May and before 30 June for the ensuing Financial Year.

The Legatus Group must provide a copy of its adopted Budget to the Constituent Councils within five (5) business days after the adoption of the Budget by the Legatus Group.

As of 4 June 2021, the following councils have advised their support.

- Adelaide Plains
- The Barossa
- Goyder Regional
- Light Regional
- Mount Remarkable
- Wakefield Regional

Traditionally membership levies have been set at the AGM.

They were subject to a 2-stage assessment which included an initial assessment against the Legatus Group SLRP Database and analysis of weighted benefit and weighted benefit cost score based on guidelines developed through the Roads Infrastructure Database Project, for application for Special Local Roads Funding.

This initial assessment was undertaken by HDS and presented to the Legatus Group Road and Transport Infrastructure Advisory Committee who undertook the second stage of the assessment.

3.2 CWMS Discussion Paper

The Chair commended the work that led to the paper and stated his view that the LGA CWMS Management Committee is now aware of the issues confronting the schemes. Frankness had been needed. Simon Millcock noted that, while the Discussion Paper had not been discussed by the Advisory Committee, the power point by Paul Chapman provided at the Conference is on the Legatus website.

3.3 Proposed CWMS training course

The Advisory Committee noted that the LGA will appoint a consultant to finalise the course content previously provided and awaits confirmation before it proceeds to issue a Request for Quotation to have the script developed for this online, on- demand training course.

3.4 Remote condition monitoring of CWMS pumps

The extension of this project to the Light and, potentially, the Wakefield Regional Councils was welcomed. It was decided that an Addendum to the original Research Agreement was needed to reflect the extension to Light and that Wakefield will keep Legatus informed of developments.

4. CWMS survey of Legatus Councils

- Lots of activity across the region in the tourism space including trails, arts (silos / tanks), streetscaping.
- Barunga West will have arts culture event coordinator starting soon.
- Roll out of the Brown Signs has been a mishmash but they are now being delivered.
- Grants overload with lots of funding opportunities but the capabilities to apply and resources available to apply and to also deliver (e.g., lack of trades people). Supportive of subregional approaches and offer from Legatus Group to assist.
- Resourcing Staffing issues including volunteers.

- a) Disability Inclusion Yorke Peninsula Tourism: The meeting noted the Legatus Group CEO report. Discussed the value of progressing accessibility and inclusiveness across the broader region.

The rail line forms the spine of the storytelling aspects with focus areas being (1) jobs / training (2) growing visitor numbers (3) community wellness (4) community capacity. This will include 3 key assets (1) Railway Station Customs House Pt Pirie (2) Gaol Site Gladstone (3) Roundhouse Peterborough. There are two creative aspects (1) Augmented and Mixed Realities (2) Illuminate along with a strong creatives team.

Community is the core to project and local involvement is paramount and will be a showcase for telling stories differently.

The meeting noted the interest from Allison in how to provide a broader regional approach and in ways to assist with gaining the stories from those locals. This project is seen as a catalyst for the Legatus Group region and will assist with developing a digital story bank.

Noted the need to include accessibility and inclusiveness into the program.

Allison offered to meet individually whilst supportive of having their creative team be part of broader regional workshop session to assist with the collaborative approach.

d) Regional Visitor Information Services Forum: Bridget Johns provided an update to the report provided by the Legatus Group CEO.

Great value in having the forum aligned to the State VIC Conference and good cross section from across the Legatus Group region with some from other regions also attending. Synergies between Silver to Sea Way and keen interest in the Storytowns Podcasts and use if other forms of mixed reality. Mayor Thomas has asked if there could be a discussion with the Legatus Group about lobbying the Valuer General to provide a rolling 5-year average valuations for councils. In particular those properties that fall under the category of Primary Production.

The Clare and Gilbert Valleys Council has not discussed it, so it is not coming in the form of a council resolution. Mayor Thomas believes the idea might be of interest to other councils as a way of dealing with rapid and large increases in land prices and thus impacting rates. Some of these increases are smoothed out by council differentials but with a rolling 5-year average would provide for more gradual change making it potentially easier for primary producers who are often income poor and the asset rich.
