I. EXECUTIVE SUMMARY

This report provides the background on the requirements by the Legatus Group relating to the South Australian Regional Organisation of Councils (SAROC) Terms of Reference calling for nominations for positions of members of SAROC.

2. RECOMMENDATION

That the Legatus Group advises the Local Government Association of SA CEO that the nominations from the Legatus Group for the two positions that become vacant on SAROC are Mayor Rodney Reid, Mayor Bill O'Brien and Mayor Ben Browne.

3. RELEVANT CORE STRATEGIES/POLICIES

4. BACKGROUND

On 4 July 2022 the Legatus Group CEO received a letter from the LGA SA CEO advising of the following:

"As you would be aware the terms of the current members of South Australian Regional Organisation of Councils (SAROC) expire at the 2022 LGA Annual General Meeting (AGM). I am seeking your assistance to call for nominations for two (2) members of SAROC from your regional grouping for a term commencing from the 2022 AGM and to remain in office until the 2024 AGM. A nomination form to be completed for each nominee to the position of member of SAROC is attached and must be received by me, no later than 5pm Friday 19 August 2022."

Note: That Port Pirie Regional Council are not eligible as Legatus Group members as their membership is through the Upper Spencer Gulf Association.

5. DISCUSSION

The Legatus Group CEO subsequently emailed all Legatus Group Mayors and CEOs on 5 July 2022 advising them of the requirements and seeking nominations by Thursday 11 August 2022. Following discussions with the Legatus Group Chair the email also included that a Special Meeting would be held on Thursday 18 August 2022 to finalise the nominations.

A meeting request with details was also sent and a further email was sent on 9 August 2022 advising of the details and information required.

The Legatus Group Charter requires that at the AGM appointments for representatives to other organisations occur. The LGA requested that nominations for the two Legatus Group allocated SAROC positions to be received by the LGA by 5 pm Friday 19 August 2022 (this is prior to the Legatus Group AGM). A request was made for the Legatus Group response to be provided directly following our AGM on 9 Sept but this was not supported by the LGA CEO.

A key eligibility criterion is that 'a person nominating as a member of SAROC must be a representative of a member on the relevant SAROC Regional Grouping and only a Council Member can be nominated to SAROC.'

The Legatus Group Charter is silent on specific SAROC appointments and in previous years the Chair and a Deputy Chair have been the Legatus Group nominations to SAROC.

The following nominations have been received seeking support from the Legatus Group to be nominated for SAROC:

- I. Mayor Rodney Reid
- 2. Mayor Bill O'Brien
- 3. Mayor Ben Browne

Mayor Kathie Bowen was recommended by Wakefield Regional Council but declined the offer.

Note that if nominations exceed the two vacant positions than the LGA will coordinate with the Legatus Group an election which follows the process outlined below:

5 September 2022	Ballot papers prepared and posted	In the event of an election being required, the regional groupings in consultation with the Chief Executive shall conduct an election (Clause 4.4.5)
17 October 2022	Voting closes	
18 October 2022	Counting of votes	The Chief Executive, in consultation with the SAROC Regional Grouping shall nominate the date, time and place for the counting of votes and shall invite each candidate and a person nominated as the candidate's scrutineer to be present (Clause 4.4.6)
28 October 2022	Final declaration of result	CEO shall declare the candidate(s) with the most votes elected at the AGM (Clause 4.4.6(b))
28 October 2022	Voting for Board Members	SAROC should meet at the conclusion of the AGM to elect 3 of its members (plus its Chair) to the Board of Directors (Clause 6.4.1 and 6.4.2) who's term of office commences after the AGM.
