6.2 On-line, on-demand CWMS training course

At its last meeting, the Advisory Committee heard from David Eggers, CWMS Manager, who undertook to investigate the delay in finalising the training course. Paul Chapman has written to David Eggers and Tom McKeller and awaits their reply.

6.3 UniSA and Yorke Peninsula CWMS expansion project

Following the December 2022 LGA CWMS Management Committee decision the Legatus Group CEO continued dialogue with UniSA and Yorke Peninsula Council on opportunities for the "Extending the capacity of regional CWMS using Constructed Floating Wetlands project".

The Legatus Group following their budget review in February 2023 confirmed an increased allocation of funding and in addition UniSA have secured a further partner SA2050 who are a South Australian technologies company with a focus on environmental, health and safety.

A revised request was provided by UniSA to the LGA CWMS Management Committee seeking support for this research. The LGA CWMS Management Committee has confirmed financial support and an inception meeting is being held on 10 May 2023.

SA2050 have been in discussions with the Copper Coast Council with a proposal for offering a treatment service to their CWMS in Wallaroo and Kadina using their technology.

SA2050 interest is in integrating their ultrafine ozone bubble technology for wastewater treatment with the natural solutions offered by the UniSA floating wetland. UniSA have advised that SA2050 is

happy to be an industry partner and contributing cash for their project and support with materials and equipment.

UniSA advise that there could be a number of IBC tanks at the Ardrossan WWTP site combining both the constructed floating wetland units inside and along with a SA2050's ozone bubble generating unit to test the effects of the two technologies individually as well as combined.

Paul Chapman has outlined that this may add further risk, complications and costs to UniSA's project.

Recommendation: that the Advisory Committee notes the report.

6.4 Regulation of CWMS in Small Regional Councils

At its last meeting, the Advisory Committee undertook to discuss regulatory issues and, "if it is thought appropriate, to invite comments on the issues raised from the appropriate regulator".

One issue commonly raised in discussions is that there is overlap among the reporting requirements. Previous contact with the regulators has established that they do not consider there to be significant overlap.

Another issue that has been raised by the Advisory Committee relates to the small size and so limited resources of some Councils and hence the greater relative impact of the significant CWMS reporting requirements. Previous discussions have made clear that the regulators have no interest in the identity of the CWMS licence holder responsible for the reporting. If an entity cannot meet the requirements, the regulators' view is that they should not continue to hold the licence.

6.6 LGA CWMS Committee / Role of Legatus Group

Following the last meeting of the Advisory Group and a report to the Legatus Group 10 February 2023 meeting the Legatus Group CEO provided the attached letters (1) Letter to SAROC Chairperson and (2) Report on the current Joint Arrangements between Legatus Group and LGA.

The Legatus Group CEO attended the 18 April LGA CWMS Managamnet Committee meeting where he spoke to the report. There has yet to be a response on the letter and the report at the time of preparing the agenda and if one arrives prior to the meeting this will be distributed.

Note that the regional workshops have been held which included 2 sessions for the Legatus Group at Balaklava and Port Pirie.

The themes outlined in the December 2022 report to the LGA CWMS Management Committee continue to be consistent and a central point of support for CWMS Councils continues to resonate. These sessions provide a great avenue for the operators to meet and discuss common issues and outline varying approaches. Major themes to emerge from the workshops include:

- Challenges associated with the small scale of operations.
- Difficulties are experienced in filling and maintaining CWMS staff positions due to the unusual skill set required.
- There is a perceived lack of appreciation of CWMS and its challenges by many elected members.
- A number of Councils declared their interest in divesting from CWMS.
- CWMS are complicated and risky assets.
- There are likely to be benefits from the LGA playing a role as a central point of support for CWMS Councils.

Recommendation: That the Advisory Committee notes the correspondence.
